



 - (4) No power back-up facilities.
 - (5) Lot of time and manpower is wasted in moving files from Khandwa Road campus to RNT campus of the university.

8. Recommended actions on Academic Audit Report:

It would be useful if appointments against the vacant posts of teaching and non-teaching staff is done by the university on priority basis.
